### Description

This exquisite 18th century oil painting possibly depicts a portrait of Maria Anna Adelheid of Hohenlohe-Bartenstien (1701-1758) in the 18th century, beautifully printed in a giltwood frame by an award-winning framer MME Boulet Mefret. The painting is an original and made using the oil painting technique. On the reverse is another painting which is very RARE to find, in the 18th century it was sometimes known for the artist to reuse the canvas due to the high cost of materials. On the back is the painting of a courting couple and a ruined tower. The noblewoman is the subject of the painting on the front and is captured in a multi-colored palette on canvas. The painting measures 70 cm in width, 83 cm in height and 6 cm in depth, making it medium in size and perfect for any art collection.
